

Perry Township Board of Supervisors  
December 9, 2010 Regular Meeting Minutes

The Perry Township Board of Supervisors held their regular meeting at 6:00 p.m. on Thursday, December 9, 2010 at the Perry Township Municipal Building. Supervisors in attendance were: John Zias and Tim Boots with Dori McElwain absent. Solicitor Greg Fox and Secretary/Treasurer, Janice Marshall and five visitors were present.

Chairman John Zias called the meeting to order beginning with the Pledge of Allegiance.

Visitor's comments: Sam Pawlowski-ashes in River Road area; Dave Weller-sprinkler system for new buildings.

Zias motioned and Boots second to accept the minutes of the November 11 and November 29, 2010 meetings. Motion passed with all in favor. Zias and Boots were present at both meeting with McElwain absent.

Zias motioned and Boots second to accept the treasurers report and pay the bills. Motion passed with all in favor. The Roadmaster, tax collection report and permit reports were presented.

Zias motioned and Boots second to pass Resolution 12-9-10-1 Budget Fund Appropriation for the 2011 year. Motion passed with all in favor.

Zias motioned and Boots second to pass Resolution 12-9-10-2 Tax Levy for the 2011 year with the taxes set at: General Fund Tax - .00129 mill; Fire Hydrant Tax - .00029 mill; Fire Apparatus Tax - .0005 mill; and Street Light Tax - .12 cents for undeveloped road frontage and .48 cents for developed road frontage. Motion passed with all in favor.

Boots motioned and Zias second to advertise the Perry Township January 3, 2011 5:00 p.m. Board of Supervisors Reorganization Meeting and the January 6, 2011 6:00 p.m. Perry Township Auditors Reorganization Meeting. Motion passed with all in favor.

Zias motioned and Boots second to pass Resolution 12-9-10-3 to close Lesnett Road in addition to Nye Road and Pine Lake Road for winter maintenance from the Merlino residence to the Beaver County Line and to purchase two "No Winter Maintenance" signs. Motion passed with all in favor.

It was decided not to contribute/donate to the Lawrence County Tourist Promotion Agency. It was decided not to respond to the request for the City of Pittsburgh for a resolution or ordinance pertaining to the gas well drilling ban.

Zias motioned and Boots second to renew the contract with Apple Mobile Medical for 2011 CDL service and employee testing. Motion passed with all in favor.

Zias read a letter received from the Lawrence County District Attorney concerning his findings about Dori McElwain's accusation that Janice Marshall was "Double Dipping" because she is doing the township secretary and the tax collection jobs. It was found that she was properly appointed and that there was no illegal or improper action done by Marshall.

Zias questioned and Boots responded to the condition of Barkley Road with all the truck traffic on the road.

Zias motioned and Boots second to adjourn. Motion passed with all in favor.
